Terms and Conditions-

1. SERVER INSTALLATION & CONFIGURATION

- Installation and configuration:
 - Web and Application Server
 - Operating Systems
 - Apache HTTP, Apache Tomcat, PHP and ProFTPd FTP server if required
- Network configuration.
 - Assign IP to the server.
 - The configuration of DNS, Default gateway etc.
 - o Configuration of backup policies and secured FTP

- Security.
 - OS level Firewall configuration.
 - Disabling unwanted services and ports.
 - Installation of updates and kernel patches.
 - Anti-virus Installation or IPTABLES Firewall
 - Securing SSH access can be given
 - Mod Security Configuration with Apache if required.

2. CUSTOMIZATION: -

- Email Sending Rights
 - Some Mail ids can only send/receive internal emails and they should not be able to send emails outside premises or domain
 - Some users can send mail to everyone, for some its can be restricted to the group as member and vise versa.
- Usage Control
 - Mail sending limit can be defined to domain
 - User space quota and attachment size can be defined through admin panel
 - Few Users should not be able to download the attachments.
- Accessibility
 - Few users can access Zimbra webmail from outside and not all users are Allowed. Admin can allow some users to give access outside office premises. Through client's firewall.
 - Few Users can access Zimbra webmail only from laptop provided or defined by company (as VPN)
 - Users who do not have any global access will not be able to use POP, IMAP, blackberry services.
- Data Availability
 - Information/Log data will be made available when it requires. Like With attachment name and extension
 - Once a new user is created through Admin, that user at the time of login can get first-time password reset option.
- Other
 - Logo Integration into the zimbra mail server.
 - Department wise mail ids can be grouped like hr@, Marketing@, staff@
 - IMAP syncing of emails
- 3. The percentage of tax should be indicated separately.
- 4. Contract Period Initially contract is for 24 Months which may be extended for further one year upon satisfactory performance of the agency as per MSWC's requirement.
