- (v) Tenders (Technical Bid & Commercial Bid) duly filled in as per the procedure stipulated in the tender document and duly signed with digital signature will be received online upto above mentioned date. It is advisable

## APPENDIX – 'A'

#### TERMS AND CONDITIONS GOVERNING CONTRACT OF PURCHASE WORK AT THE WAREHOUSE OR SUBSIDIARIES OF THE MAHARASHTRA STATE WAREHOUSING CORPORATION

#### I. **DEFINITIONS:**

- 1) The term '**Contract**' shall mean and include the invitation to tender, instructions to tenderers, the tender & its appendices, acceptance of tender and such general & special conditions as may be added to it.
- 2) The term 'Corporation' shall mean Maharashtra State Warehousing Corporation (in short form M.S.W.C.) established under Section 18(i) in the Warehousing Corporations Act, 1962 and will include its Chairman & Managing Director / Other authorized Officers of the Corporation and its successor Or successors and assignees.
- 3) The term '**Contractor**' shall mean and include the person or persons, firm or company, Corporation or Co-operative Society with whom the contract has been placed including their heirs, executors, administrators, successors and their permitted assignees, as the case may be.
- 4) The term 'Services' shall mean the performance of any of the items of work enumerated in Appendix-'C' and as elaborated in clauses therein including such auxiliary, additional and incidental duties services and operations may be indicated by the Chairman & Managing Director/Other authorized Officers of the Corporation or Warehouse authorities of the Maharashtra State Warehousing Corporation.
- 5) The term **'Contract Rates**' shall mean the rates of payment for terms of work accepted by the Chairman & Managing Director of Maharashtra State Warehousing Corporation.
- 6) The term '**Godown**' shall mean & include godowns, warehouses, open storage space, open platform/ plinths constructed, hired or occupied by the Maharashtra State Warehousing Corporation or hereafter be constructed or acquired by it, or indented for specific purpose by Corporation.
- 7) The term '**Supplies**' / '**Stores**' shall mean and include the product for which tender has been invited by the Corporation, with its specification mentioned therewith.

#### **II. OBJECT OF THE CONTRACT:**

The Contractor shall tender all or any of the services given in the schedule of work and details set out in Appendix-'C' and discharge duties and responsibilities mentioned to herein as and when necessary and as directed from time to time by the Corporation authorities together with such additional auxiliary and incidental services and operations as may be indicated by the Corporation authorities and which are not inconsistent with these terms & conditions

#### **III. PARTIES TO THE CONTRACT:**

- 1) The parties to the contract are the contractor and the Maharashtra State Warehousing Corporation.
- 2) The persons signing the tender or any other documents forming part of the tender on behalf of another person shall be deemed to warrant that he has the authority to bind such other persons or firm or company or Contractor as the case may be in all matters pertaining to the contract. If, on enquiry it is found that the person concerned has no such authority, the Chairman & Managing Director, Maharashtra State Warehousing Corporation may without prejudice to other civil and criminal remedies terminate the contract and hold the signatory liable for all costs and damages consequent on such termination.
- 3) Notices or any other action to be taken by Corporation be given/taken by the Chairman & Managing Director of the Maharashtra State Warehousing Corporation or any other officer duly authorized to the purpose and on behalf.

#### IV. CONSTITUTION OF CONTRACTOR:

- 1) Contractor shall at the time of submission of tender declare whether they are sole proprietary concern or registered partnership firm or Company. The composition of partnership names of partners, Director or as the case may be, shall also be indicated. The Contractor shall also nominate a person in whose hands the active management and control of the work relating to the contract during tenure of the contract should be. The person so nominated shall be deemed to have power of attorney from the contractors in respect of the contract and whose acts shall be binding on the Contractors.
- 2) The Contractor shall not make, during the currency of the contract and without the prior approval of the Corporation, any change in the constitution of the firm. The contractor shall notify to the Corporation the death/resignation of any of their partners/directors immediately on the occurrence of such event. On receipt of such notice, the Corporation shall have the right to terminate the contract.

#### V. RATE CONTRACT:

The tenderer should ensure that rates should be quoted in Appendix- D of contractor's offer. Rates shall be quoted in per No F.O.R. destination anywhere in Maharashtra, covered adequately by insurance and must be inclusive of cost of packaging, handling, insurance charges and all applicable taxes except GST.GST shall be paid extra at applicable rates subject to submission of tax invoice as per rules under GST.

#### VI. SUBLETTING:

The Contractor shall not sublet, transfer or assign the contract or any part thereof without the prior written permission of Chairman & Managing Director of the Corporation. In the event of the contractors contravening this condition the Corporation shall be entitled to place the contract elsewhere on the contractor's account and at their risk and the contractors shall be liable for any loss or damage which the Corporation may sustain consequent of or arising out of such placing of the contract.

#### VII. VOLUME OF WORK:

The Corporation do not guarantee any definite volume of work or any particular pattern of services at any time or throughout the period of the contract. The mere mention of any item of work in the contract does not by itself confer a right on the contractor to demand that the work relating to all or any item thereof should necessarily or exclusively be entrusted to them. Corporation will have the absolute right to appoint one or more contractors for any or all services mentioned hereunder and to divide the work as between, such contractors in any manner that the Corporation may decide and no claim shall be against the Corporation by reasons or such division of work.

#### VIII. PRICE VARIATION:

No price variation clause will be applicable for the contractual period or extended period under the provisions of terms & conditions.

- IX A) In any case in which under any clause or clauses of this contract the contractor has rendered himself liable for termination of contract for breach of the terms & conditions of this contract including the abandonment of the work owing to any reason, the Corporation shall have power to adopt any of the following courses as may be deemed best suited in the interest of the Corporation.
  - (i) To rescind the contract (of which the rescission notice in writing to the contractor from the Corporation shall be conclusive proof) and in that case, the Security Deposit in any form of the Contractor shall stand forfeited and be absolutely at the disposal of the Corporation.
  - (ii) After rescinding the contract, time being the essence of this contract, the Corporation shall be at liberty to carry out the work or part of the work by engaging any other agency on contract or otherwise as per the exigency of the situation at the risk and cost of the contractor who is under the liability for action for termination of contract.
- **IX** B) In the event of the Contractor failing to comply with the instructions given by the Corporation to him, the Corporation or an officer authorized by it may after due notice, in writing arrange for the alternative arrangements through any other contractor or any other agency at the risk, cost and expenditure of the Contractor who shall bear and pay all additional expenditure incurred by the Corporation on that behalf. Such extra expenditure incurred by the Corporation shall be recoverable from Contractors Bills or Security Deposit, Bank Guarantees.
- X) All taxes/charges to the Central/State Government/ Local Bodies, etc. on the vehicles employed by the contractor, for the work undertaken by the contractor will be paid by the contractor and no claim whatsoever will be applicable against the Corporation on this account.
- XI) TAXES:
- (i) The taxes existing & wherever levied by the Central/ State Govt, the same will be borne /paid by the contractor.
- (ii) The TDS method for recovery of taxes will be adopted as per procedure/guidelines of Central/State Government.

(iii) In relation to this contract all taxes are applicable excluding GST levied or if any other tax / taxes levied by State Government / Central Government and MSWC has to pay or has paid such a tax/tax it should be compensated by the contractors; by allowing MSWC to adjust such amount/s of tax/taxes in his payments in spite of statutory liability of whomsoever.

#### XII. SET OFF:

Any sum of money due and payable to the contractor including security deposit, under this contract may be appropriated by the Corporation and set off against any claim of the Corporation for the payment of any sum of money arising out of or under any other contract made by the Contractors with the Corporation.

#### XIII. PERIOD OF CONTRACT:

- 1) The contract period shall be for a period of one year. It can be extended for a further period of 6 months if mutually agreed at same rate & terms and conditions.
- 2) The Chairman & Managing Director reserve the right to terminate the contract at any time if the performance of the contractor is found unsatisfactory by giving 30 days' notice in writing to the contractor. The contractor is not entitled for any compensation by reason of termination.
- 3) Corporation reserves the right to terminate the contract, Agreement /arrangements at any time for any reason by giving 30 days' notice to the contractor. However, in the event of any breach or non-performance of the any of the conditions of the agreement, Corporation reserves the right to terminate the agreement with immediate effect without giving any notice.
- 4) If the performance of the contractor not found satisfactory, the Corporation will blacklist the contractor / agency for the period which Corporation may deem fit at appropriate time.

#### **XVII. AGREEMENT:**

The Contractor shall give an agreement in prescribed format within 7 days from the date of intimation of accepting the tender by the Corporation.

#### XVIII. SECURITY DEPOSIT:

- 1) The contractor shall pay security deposit amount as informed by the Corporation within 7 days from the date of purchase order. This security deposit shall be paid by demand draft drawn on any nationalized bank or schedule bank in favour of M.S.Warehousing Corporation, payable at Pune. As stated above, the contractor shall be eligible to execute the agreement on the requisite value of stamp duty as communicated. The acceptance of tender shall be effective only after concluding the agreement by the contractor as above.
- 2) The security deposit will be refunded to contractor due and satisfactory performance be refunded, of service and completion of all obligations by the contractor under the terms and conditions of the contract and on submission of 'No dues' certificate subject to such deductions from the security deposit as may be necessary for making up of the Corporation's claims against the contractor.

#### XIX. ARBITRATION:

All disputes and difference arising out of or in any touching or concerning this agreement whatsoever (except as to any matter the decision of which is expressly provided for in the contract) shall be referred to the sole arbitration of Chairman and Managing Director or any person including any officer of the Corporation appointed by the Chairman & Managing Director of the Maharashtra State Warehousing Corporation. It is also a term of this contract that no person other than a person appointed aforesaid should act as an Arbitrator. Provided further that any demand for arbitration under the contract shall be in writing and made within one year of the date of termination or completion of the contract, otherwise the contractor shall be deemed to have been waived and absolutely barred and the Corporation shall be discharged and released of all liabilities whatsoever under the contract. The costs of and in connection with arbitration Act, 1940 shall apply to arbitration proceeding under this clause.

#### XX. LEGAL JURISDICTION:

For any legal dispute, suit, application, claims or proceeding of any kind Whatever in respect of, arising out of directly indirectly or incidental to anything in respect of this contract shall be filed exclusively Subject to Pune jurisdiction.

## <u>APPENDIX – E</u>

#### **GENERAL TERMS & CONDITIONS OF CONTRACT**

#### **Definitions and Interpretation:**

I. In the contract and the General and Special conditions governing it, unless the Context otherwise requires:

a) "Acceptances of Tender" means the letter/memorandum communication to the contractor the acceptance of his tender, and includes an advance acceptance of his tender telegraphically.

b) "Corporation" means the Maharashtra State Warehousing Corporation established under section 18 of Warehousing Corporation Act, 1962.

c) "Consignee" included the officer to whom the stores are required to be dispatched by road.

d) "Contract" means the invitation to tender inclusive of instructions to tenders, and subject to such subsequent modifications if any, the rates quoted by the tenderer in the tender, acceptance of tender the general and special conditions, annexed to the Invitation of Tender and such other conditions, if any, may be mutually agreed upon in writing. No terms and conditions mentioned in the tender of the tenderer which is in consistent with invitation of the tender and general conditions of contract shall be deemed to be the part of the contract unless it is expressly agreed to by communications of the acceptance of the tenders.

e) "Contractor" means manufacturer who has agreed to supply the material the person with whom the contract is made and included his heirs, executors, administrators, successors and permitted assignees, as the case may be.

f) "Inspecting Officer" means officer(s) of Maharashtra State Warehousing Corporation authorized for the purpose of inspection of the stores or work under the contract.

g) "Material" means the goods specified in the schedule which the contractor has agreed to supply under the contract.

h) "Unit and Quantity" means the unit and quantity specified in the schedule.

- II. Terms and expressions not herein defined shall have the meanings assigned to them in the Indian Sale of Goods Act, 1930 or the Indian Contract Act. 1872, or the General Clause Act. 1897 as the case may be.
  - (a) Parties: The parties to the contract are the contractor and Maharashtra State Warehousing Corporation having its Head Office at 583/B, Market Yard, Gultekadi, Pune – 411037 and in case of orders placed by Maharashtra State Warehousing Corporation and the contractor.
  - **b)** Address of the Contractor for notices and communications on behalf of the purchaser : For all purpose of the contract including arbitration thereunder, the address of the contractor mentioned in the tender shall be the address to which all communications & notices are addressed to the contractor shall be considered to be duly served if the same shall have been delivered, left, or posted by registered post unless the contractor notifies a change by a separate letter sent by Registered post to the Chairman & Managing Director,

Maharashtra State Warehousing Corporation, 583/B, Market Yard, Gultekadi, Pune -411037.

III. Authority of the Chairman & Managing Director or an officer acting on behalf of him. For all purpose of the contract including arbitration, proceedings thereunder, the Chairman & Managing Director of the Corporation or any other officer authorized to act on his behalf shall be entitled to exercise all the rights and powers of the purchaser.

### IV. <u>Responsibility of the Contractor for executing the contract</u>.

1. Risk in the stores: The contractor shall perform the contract in all respects in accordance with the terms and conditions thereof. The stores in the joint possession of the contractor, his agents or servants, a carrier at the risk of the contractor until their actual delivery to the consignee at the stipulated place or destination. The contractor shall be responsible for all cause(s) what-so-ever while the stores after approval by the Inspecting officer misdeliver loss, destruction, damage, deterioration of goods entrusted to such carrier by the contractor for transmission to the consignee and also responsible to make claim against the Railway administration or other carrier(s).

2. Consignee right of rejection : Not withstanding any approval which the Inspecting officer of the Corporation may have given in respect of the stores or any of the materials or other particular or the work or workmanship invited in the performance of the contract (Whether with or without any test carried out by the contractor or the Inspecting officer or under the direction the Inspecting Officer) it shall be lawful for the consignee on behalf of the purchaser to reject the stores or any part portions or consignment thereof within a reasonable time after actual delivery thereof to him at the place of destination specified in the schedule, if such stores or part portion or consignment thereof is not in all respects in conformity with the specifications whether on account of any loss, deterioration or damage before dispatch or delivery or during transit or otherwise however. Provision contained in the clause relating to the removal of stores rejected by inspecting officer shall mutatis mutandis apply to stores rejected by the consignee as here in provided.

3. Subletting and assignment: Save with the previous constant in writing of the Corporation the contractor shall not in any manner sublet, transfer or assign the contract or any part thereof or interest therein whatsoever.

4. Assistance to the Contractor: The contractor shall be solely responsible to procure all the material required for the fulfillment of the contract.

## V. <u>Quotations of rates by contractor</u>:

1. The price quoted by the contractor shall be reasonable and not be higher than the price usually charged by the contractor for stores of the same nature, class or description to the other purchaser.

2. If it is discovered that the contractor has contravened the above condition than without prejudice to any other action, which might be taken against him, the

Corporation shall have the right (1) to revise the price at any stage so as to bring it in conformity with the price charged to other purchasers and to pay for the stores already supplied and finally accepted at the rates so revised, (2) to terminate the contract in its entire or in part in case when the part of the stores has already been supplied and accepted and in that event the contractor will not be entitled to claim any compensation from the Corporation for the contract or any part thereof so cancelled.

### VI. Security Deposit:

1. On acceptance of the tender, the contractor shall at the option of the Corporation and within the period specified by it furnish such security deposit for due performance of the contract as by way of Demand Draft drawn in favour of Maharashtra State Warehousing Corporation, on any Nationalized Bank payable at Pune.

(i) If the contractor having been called upon by the Corporation to furnish security fails to do so within the specified period, it shall be open to the Corporation.

(a) to recover from the contractor the amount of such security deposit by deducting the amount from the pending bills of the contractor under this contract or any other contract with the Corporation, or

(b) to cancel the contract and to forfeit the earnest money without prejudice to its further rights to purchase of authorize the purchase of the stores at the risk and cost of the contractor.

(ii) The security deposit shall carry no interest and no claim shall lie against the Corporation in respect of interest under any circumstances.

2) If the contractor fails or neglects to observe or perform any of his obligations under the contract, it shall be open to the Corporation to forfeit either in whole or in part, in its absolute description, security deposit furnished by the contractor or to appropriate the security deposit or any part thereof in or towards the satisfaction of any sum due to be claimed for any damages, losses charges, expenses, or cost that may be suffered or incurred by the corporation. Save or as aforesaid if the contractor duly performs and completes the contract in all respects and present an absolute 'No Demand Certificate' in the prescribed form the Corporation shall refund the security deposit within the period of six months of the receipt of supplies at destinations in conformity with the specifications and other terms and conditions, after deducting all costs that the Corporation have incurred.

(v) The decision of the Corporation in respect of damages, losses, charges costs or expenses shall be final and binding on the contractor.

(vi) In the event of the security deposit being insufficient or if the security has been wholly forfeited the balance or the total sum recoverable as the case may be, shall be deducted from any sum then due, or which at any time thereafter may become due to the contractor under this or any other contract with the Corporation. Should that sum also be not sufficient to cover the full amount recoverable the contractor shall pay to the Corporation and demand the balance due.

(vii) Extension of time shall be granted only to such suppliers who have executed the agreement and furnished the requisite security deposit.

#### VII. LAPSE OF SECURITY DEPOSIT

Security Deposits which are not claimed within three years from the date of last supply or date of completion of work in all respects or payment of balance amount of final bill or the guarantees period or the period of contract, whichever is later, shall be treated as having irrecoverably lost/become time barred.

## VIII. Specification/s etc.

The stores shall be of the best quality and shall conform to relevant specifications mentioned in Appendix B, if any, in force at the time of placing of the order, and shall otherwise be in accordance with the particulars specified in the schedule as per any definition has been expressly specified in the acceptance of the tender.

## IX.<u>Packing</u>:

1. The contractor shall pack at his own cost the stores sufficiently and properly for transit by rail, road, so as to ensure they are being free from loss or damage physical or chemical on arrival at their destination.

2. Unless otherwise provided in the schedule all containers (including packing cases, boxes, tins, drums and wrappings) in which the stores are supplied by the contractor shall considered as non-returnable and their cost as having been included in the contract prices.

3. Without prejudice to other rights under this contract or otherwise, the Inspecting officer, may reject the stores if the stores are not packed and/or marked as aforesaid and in case where the packing materials are separately prescribed if such materials are not in accordance with the terms of the contract. Such rejection of the stores by the Inspecting Officer shall be final and binding on the contractor.

4. Each consignment shall contain a packing note specifying the name and address of the contractor, number and date of the acceptance of tender or supply order and the designation of the purchase officer or office issuing the supply order the description of the stores and the quantity contained in such consignment.

## X. <u>Delivery</u>

1. The contractor shall deliver the stores in accordance with the conditions of contract at the time and the place and in the manner specified in the schedule.

2. Passing of Property: Property in the stores shall not pass to the purchaser unless and until the stores have been delivered to the consignee as the case may be, in accordance with the condition of the contract. In case where local delivery or free delivery at the specified destination is stipulated, state the Lorry Receipt, consignment notice, or the bill of lading, Warehouse Certificate as the case may be, in accordance with the terms of the contract.

3. The purchaser shall not be liable to assist in securing or to arrange for or provide transport to the contractor.

4. Facilities to the Inspecting Officer: The contractor shall allow reasonable facilities and free access to his works and records to the Inspecting Officer or such officer as may be nominated by the Corporation for the purpose and assisting the progress of the deliveries under the contract.

5. The purchaser shall not be bound to apply for delivery but the contractor shall where the stores are ready for inspection and test, send a notice in writing, specifying the place where inspection is offered to the concerned officers of the Corporation who shall on receipt of such notices notify to the contractor, the date and time when the stores would be inspected.

6. Failure and Termination: If the contractor fails to deliver the stores or any installment thereof within the period fixed for such delivery in the schedule or at any time repudiates the contract before the expiry of such period, the Corporation may without prejudice to the right of the purchaser to recover damages for breach of the contract may exercise either of following options.

(i) Recover from the contractor, such percentage not exceeding 10% of the price of any stores which the contractor has failed to deliver within the period fixed for delivery in the schedule for each month or part of a month during which the delivery of such stores may be in arrears where delivery thereof is accepted after expiry of the aforesaid periods or

(ii) Purchase or authorize the purchase elsewhere without notice to the contractor on the account at the risk of contractor, of the stores not so delivered or others of similar description (where stores exactly comply with particulars are in the opinion of the Corporation, which shall be final not readily procurable) without the contract in respect of the installments not yet due for delivery or

7) Cancel the contract or a portion thereof and (i) purchase stores not so delivered or others of similar description (which stores exactly complying with particulars are not in the opinion of the corporation, which shall be final, readily procurable at the risk and cost of the contractor and where action is taken under sub-clause (ii) above and sub-clause (iii) the contractor shall be liable for any loss which the purchaser may sustain on that account provided the purchase, or an agreement to purchase such is made in case of failure to deliver the stores within the period fixed for such delivery in such schedule. The contractor shall not be entitled to any gain on such purchase and the manner and method of such purchase shall be necessary for the purchaser to serve a notice of such purchase on the contractor and claim difference between the contract price and the price prevailing at the time of breach of the contract. iv) Whenever any claim for the payment of a sum of money arises out of or under the contract against the contractor, the Corporation shall be entitled to recover such sum by appropriating the whole or in a part the security deposit deposited by the contractor.

In the event of security deposit being insufficient the balance shall become immediately recoverable from the contractor and till realization of such amount from the contractor, the Corporation shall have lien on all unpaid bills of the contractor whether relating to this or any other contract of the contractor with the Corporation and also on security deposit and earnest money relating to other contract.

8. Notification of delivery: Notification of delivery or in regard to each and every installment shall be made to the purchase officer. The contractor shall further supply to the consignee, packing accounts quoting numbers of the acceptance of tender and or supply order and date of despatch of the stores. The Lorry receipt of the consignment note shall be sent to the consignee by registered post immediately on the realisation of the stores. The contractor shall bear and reimburse to the purchaser demurrage. Charges, if any, paid by reason of delay on the part of the contractor in forwarding the Railway Receipt or the consignment note as the case may be.

## Xl. Inspection and Rejection:

1. Facilities for Test and Examinations the contractor shall, at his own expense afford to the inspection officer all reasonable facilities as may be necessary for satisfying himself that the stores are being and/or have been manufactured in accordance with the specifications and / sample. The Inspecting Officer shall be full and free access at any time during the execution of the contract to the contractor's work for the purpose aforesaid, and he may require the contractor to make arrangements for inspection of the stores or any part thereof or any material at his premises or at any other place specified by the Inspecting Officer.If the sample does not confirm is not in conformity with the specifications the supplier shall pay such compensation as may be decided by the Chairman & Managing Director whose decision in the matter shall be final and binding. 2. Method of Testing: The inspecting officer shall have right to adopt such manner and method of testing as he may think it proper and the contractor should not be entitled question such manner or method on any grounds whatsoever.

3. Inspecting officer: Final authority and to certify performance the Inspecting Officer shall have the powers.

(i) to certify that they cannot inspected as are not in accordance with the contract owing to adopting of any unsatisfactory method of manufacture, before any stores or part thereof are submitted for inspection.

(ii) to reject any stores as not being in accordance with the particulars.

(iii) to reject the whole of the installment tendered for inspection, if after inspections of such portion thereof as he may in his discretion think fit, he is satisfied that the same is unsatisfactory.

(iv) to mark the rejected stores with a rejection mark so that they may be easily identified if resubmitted.

4. Consequence(s) of Rejection: If on rejection of any of stores by Inspecting Officer or consignee at the destination, the contractor fails to make satisfactory supplies within the stipulated period of delivery the corporation shall be at liberty to:

(i) Allow the contractor to resubmit the stores in replacement of those rejected, within a specified time, the contractor bearing the cost of freight and other expenses in connection thereof, if any, on such replacement without being entitled to any extra payment on that account: or

(ii) Purchase the quantity of the stores rejected either of the same description or of similar description (When stores exactly complying with particulars are not in the

opinion of the Corporation which shall be final, readily available) without notice to the contractor at his risk and cost and without affecting the contractor's liability as regards the supply of any further installment due under the contract, or

(iii) Cancel the contract and (a) purchase the stores of the same description complying with particulars at the risk and cost of the contractor or (b) claim difference between the contract price or the price prevailing at or about the time of purchase

5. Inspecting Officer's Decision as to Rejection Final The Inspecting officer's decision as regards the rejection shall be final and binding on the contractor.

6. Notification of Result of Inspection: Unless otherwise provided in the specifications in the schedule, the examination of the stores will be made as soon as practicable after the same has been submitted for inspection and the result of the examination will be notified to the contractor.

7. Marking of Stores: The contractor shall if so required at his own expenses mark or permit the Inspector to mark all the stores put up for inspection

8. Removal or Rejections:

(a) Any stores submitted for inspection at a place other than the premises of the contractor and rejected shall be removed by the contractor within fourteen days of the date of receipt of intimation of such rejection.

(b) Such rejected stores shall under all circumstances lie at the risk of the contractor from the moment of such rejection and if such stores are not removed by the contractor within the period afore mentioned, the Inspecting officer may either return the same to the contractor at his risk and cost by such mode of transport as the Corporation, or inspecting officer may select, or dispose of such stores at the contractor's risk on his account and retain such portion of proceeds as may be necessary to cover any expense incurred in connection with such disposal. The purchaser shall also be entitled to recover handling and storage charges for the period for which the rejected stores are not removed.

9. Inspection Notes:

On the stores being found acceptable by the Inspecting Officer he shall furnish the contractor with necessary copies of inspection Notes duly completed for being attached to the contractor's bill in support thereof.

#### XII. <u>CLAUSE – RECOVERY OF SUMS CLAIMED</u>:

Whenever any claim or claims for payment of a sum of money arises out of or under the contract against the contractor, the Corporation shall be entitled to withhold and also have a lien to retain such sum or sums in whole or in part from the security deposit for the purpose aforesaid the Corporation shall be entitled to withhold and have a lien to retain to the extent of such claimed amount or amounts referred to above from any sum or sums found payable to the contractor under the same contract or any other contract with the Corporation pending finalization or adjudication of any such claim.

## XIII. Payments under the contract:

Payment for the stores for each consignment thereof will be made to the supplier by the MSWC, Pune subject to the recovery of liquidated damages, if any, on account of

the deleted supply of stores on submission of the pre-receipted bill in accordance with the following procedure -100% of the cost of the stores on each consignment thereof shall be paid on production of the following documents.

- Receipt of WHB-12 (Certificate regarding receipt of material by respective destination)
- Whichever Tax is applicable its registration No. is mentioned on Bill / Invoices & its amount should be dully mentioned in the bill although the quoted rate is consulate should match to the rate finalized as per T & C of Tender.
- Inspection Note copy No.4 duly signed by the consignee

## XIV. <u>Indemnity</u>:

The contractor shall at all times indemnify the purchaser against all claims which may be made in respect of the stores for infringement of any right protected by patent, registration of design or trade mark.

## XV. Insolvency and Breach of contract:

1) The corporation may at any time by notice in writing summarily determine the contract without compensation to the contractor in any of the following events, that is to say:

i) If the contractor, being an individual or if a firm, any partner thereof shall at any time be adjudged insolvent or shall have a receiving order or order for administration of his estate made against him or shall take proceedings for composition under any insolvency act for the time being in force or made any conveyance or assignment of his effects or into any arrangements of composition with his creditors or suspend payment or if the firm be dissolved under the partnership act; or

(ii) If the contractor being company is wound up voluntarily or by the order of a court or a receiver liquidator or manager on behalf of the debenture holders is appointed or circumstances shall have arisen which entitle the court or debenture holders to appoint a receiver, liquidator or manager or

2)

If the contractor commits any breach of the contract not herein specifically provided for provided always that such determination shall not prejudice any right of action or remedy which shall otherwise be open to the purchaser.

## XVI. <u>Arbitration</u>:

All disputes and differences arising out of or in any way touching or this agreement whatsoever (except as any matter the decision of which is expressly provided for in the contract) shall be referred to the sole arbitration of the Chairman & Managing Director or the person appointed by the Chairman & Managing Director, Maharashtra State Warehousing Corporation, Pune to solve the arbitration. There shall be no objection to any such appointment, that the person appointed is an employee of the Corporation, that he had to deal with the matter to which the contract relates.

Provided further that any demand for arbitration in respect of any claim (s) of the

contractors under the contract act shall be in writing and made within one year of the date of termination or completion (expiry of the period) of the contract and where this provision is not complied with the claim (s) of the contractor shall be deemed to have been waived and absolutely barred and the corporation shall be discharged and release of liabilities under the contract.

It is further provided that the arbitrator may, from time to time with the consent or the parties, enlarge the time for making and publishing the award.

The Venue for arbitration shall be such place as may be fixed by the arbitrator in his sole discretion.

The costs of arbitration shall be borne by the parties as per the decision of the arbitrator.

### XVII <u>TRANSIT INSURANCE</u>:

The purchaser will not pay separately for Transit Insurance and the Supplier will be responsible till the entire stores contracted for arrive in good condition at destination. The transit risk in this respect may be covered by the Contractor by getting the stores duly insured, if he so desires. The insure cover shall be obtained by the Contractor in his own name and not in the name of the consignee. The consignee will as soon as possible but not later than 45 days from the date of arrival of stores at destination notify the contractor of any loss or damage to the stores that may have occurred during transit.
