### **SCOPE OF WORK**

1. Cleaning and tightening loose nuts, bolts & the Mechanical parts of the weighbridge and providing oil, grease & labor required for the Job.  
Periodicity: Quarterly

2. Cleaning the weighbridge and weighbridge cabin, removing the dust, mud, debris spiders' etc. and dispose of the same with all leads and lifts outside the warehouse complex.  
Periodicity: Quarterly

3. Cleaning and removing the dust from key Board Printer, Battery, UPS, Electronic Digital Display by opening the box/case. The agency is not expected or permitted to dislocate and refit any part of Electronic Digitizer/Digital Display and above said parts unless otherwise instructed in writing by the competent authority of the Corporation.  
Periodicity: Quarterly

4. Verification for correctness of weighbridge and Stamping. The weights required for the above job will be supplied by the Department i.e. MSWC at work site, however, labor, equipment's, machineries will have to be arranged by the agency whenever the weighbridge goes out of order.  
Periodicity: Yearly.

5. Annual Stamping.

a) Verification and calibration of 50 MT/60 MT weighbridge for annual stamping of weighbridge. The weights shall be provided by the Department at work site. However, the labor will have to be arranged by the agency.


b) Paying the required Govt. fees to the Department of Weights and Measures in the name of Maharashtra State Warehousing Corporation and submitting the original payment receipt to the Warehouse In charge.

c) Obtaining the annual stamping verification Certificate from the Inspector of Weights and Measurement Department and submitting to Storage Superintendent, M. S. Warehousing Corporation, Nagpur Region.

#### **NOTE:**

- 1) The agency shall attend break down call within 24 hours, otherwise penalty will be charged as may be decided by the Corporation.
- 2) The agency shall take all necessary precautions for the safety of the works and preserving their health while working in such job as require special protection and precautions



**TERMS AND CONDITIONS**

- 1) This form is the Quotation cum Agreement for the execution and completion of piece work at the rates agreed upon without reference total quantity of the work to be done.
- 2) The agency shall be quoted the rates as per Schedule B with inclusive of all taxes/labor charges but excluding GST.
- 3) Security Deposit payable at the time of acceptance of this offer Rs.10,000/-
- 4) The period of AMC is **12 months**.
- 5) Agreement on stamp paper of requisite value shall have to be executed for works amounting more than Rs. 10,000/- put to Quotation.
- 6) **Payment Terms:** -
  - a) 50% Payment will be paid after obtaining the Annual Stamping Verification from the Inspector of Weight & Measurement Department.
  - b) 25% payment will be paid after completion of six months AMC period for the date of work order.
  - c) 25% payment will be paid after successful completion of AMC Contract period.
- 7) **Compensation for Delay:** If the agency fails to complete the specific work as per requirement of Storage Supdt/Regional Head, the agency will be penalized. In grave, situation agency may be blacklisted for 3 years from MSWC.
- 8) **Work to be get done from other agency:** If the agency fails to attend the repairs works within 24 hours from the time of intimation, the same will be got executed from other agency at the agency's risk & cost.
- 9) **Forfeiture of Security Deposit and Termination of Contract:** - If the action under clause No. 8 is taken against the agency; the contract will be terminated at any time for the failures in attending the job as expected & S.D. will be forfeited.
- 10) Government stamping fee will be paid by the MSWC separately however original receipt to be produced by the contractor for release of payment.
- 11) TDS if any will be deducted at source as per the provisions of the relevant Acts.
