  - 2. Authorized Service partner/dealer/ Manufacturer certificate.
- 4. Price: The rate should be inclusive of taxes, installation and support for warranty period. The percentage of tax should be indicated separately in the invoice along with HSN/SAC Code.
- 5. Delivery and installation: Delivery and installation of biometric license along with required configuration should be done within 15 days from the date of this purchase order.

- 6. Period of Contract The period of contract is for one year and may be extended for next one year as per MSWC requirement with same rate and terms and condition.
- 7. Warranty one year warranty from the date of installation along with offshore support. The same may be extend for one years with same rate and terms and conditions as per requirement of MSWC.
